






## ROBERT G "HAP" FRY JR.



His children live in New Jersey, Texas and Colorado, while his grandchildren are spread out even further - residing in California, Florida, New Jersey, Texas and Switzerland. "I am very proud of all my children and grandchildren and what they have been able to accomplish," Fry said.

In addition to spending time with Badger and his family, Fry also frequently spends time with friend, Sharon Miller. "We love dancing and traveling together, and we've been to Ireland, Belgium, and The Netherlands," he explained. "We are looking forward to and currently planning a European cruise!"
